# <u>Timeline of the Exposure and Prosecution of Genocide in</u> <u>Canada, and Abroad</u>

# <u>1995-2015</u>

#### <u> 1995</u>

<u>January 23</u>: Reverend Kevin Annett is fired from his Port Alberni church for exposing theft of Ahousaht land by his employer, the United Church of Canada, the government and MacMillan-Bloedel-Weyerhauser Ltd. Kevin is prevented from working elsewhere in the United Church.

<u>July 10:</u> Kevin's firing is reported in the *Vancouver Sun ("Minister who tried to bring natives into the fold fired by his church"* by Stephen Hume)

<u>September 5</u>: Kevin commences a doctoral studies program at the University of British Columbia (UBC), accessing newly acquired microfilmed archives of Indian residential school records. An average death rate of more than 40% is discovered by Kevin to have occurred in the schools.

<u>December 18-20</u>: The first media reports appear of killing of residential school children, from statements by eyewitnesses Harriett Nahanee, Jack McDonald and Archie Frank, which are surfaced at a public protest by Kevin Annett at United Church headquarters in Vancouver. (*Vancouver Sun* and *Province*)

<u>December 24:</u> Kevin's wife Anne McNamee, prompted and paid by United Church official Brian Thorpe and lawyer John Jessiman, announces she will divorce him.

# <u>1996</u>

<u>January 17</u>: The very day Kevin and Anne first appear in divorce court, *Vancouver Sun* reporter Doug Todd, a paid associate of United Church official Brian Thorpe who arranged Kevin's firing, runs an article describing the United Church's now-defunct demand that Kevin undergo a "psychiatric evaluation".

<u>February 1</u>: First class action lawsuit is brought by residential school survivors against United Church and federal government, in British Columbia Supreme Court. Kevin is an adviser to four of the plaintiffs.

<u>February 4:</u> United Church national office decides to "de-list" Kevin or expel him from ordained ministry, despite the recommendation of local Presbytery officials that Kevin simply undergoes "retraining".

<u>April 4:</u> Kevin loses custody of his two children and is court ordered to leave the family residence.

<u>April 15</u>: Kevin and Harriett Nahanee launch a "healing and justice" circle for residential school survivors at the Carnegie Centre in downtown Vancouver; Kevin shares evidence of deaths and crimes at the school obtained from his doctoral research with Circle members and local media.

<u>May 3</u>: United Church head office issues statement to all 2,200 of its clergy ordering them not to associate with Kevin Annett and to report his activities.

<u>August 29</u>: United Church "De-listing" trial of Kevin commences in Vancouver (see Counter Report of the Trial at <u>http://itccs.org/2011/11/17/report-on-the-expulsion-of-united-church-</u> <u>minister-reverend-kevin-annett-from-his-ministry-and-livelihood/</u>). Kevin is denied legal counsel and is not told of the charges against him or shown any evidence.

# <u>1997</u>

<u>January-February</u>: Kevin is quoted in the *Nanaimo Daily News* and the *Victoria Times-Colonist* accusing United Church officials of killing native children, based on documents and eyewitness statements by Harry Wilson and Dennis Tallio.

<u>March 6:</u> United Church of Canada votes to permanently "de-list" or permanently remove Kevin from United Church ministry, despite their inability to prove that he is unfit for such an office.

<u>May-August</u>: Evidence revealed at the first Indian residential school court trial (*see February 1, 1996*) confirms Kevin's claim of killings at the Alberni school. In response, Kevin, Harriett Nahanee and other survivors begin picketing and protesting at United Churches in Vancouver on Sunday mornings.

<u>November 5:</u> Kevin and Harriett meet with officials of IHRAAM (*International Human Rights Association of American Minorities, a United Nations NGO*) and share evidence of crimes at west coast residential schools. IHRAAM

officers Rudy and Diana James recommend to their head office that a "war crimes Tribunal" into these crimes be convened in Vancouver.

<u>December 1</u>: Over 5000 individual lawsuits have been commenced by other residential school survivors against the United Church as well as the catholics and the anglicans.

#### <u> 1998:</u>

<u>February 9</u>: The first public forum into residential school crimes is held in downtown Vancouver, organized by Kevin, Harriett and IHRAAM. Three hundred people attend, most of them aboriginal. Rudy James publicly announces to the press that a residential schools "war crimes Tribunal" will be convened that summer in Vancouver.

<u>March 1</u>: In Vancouver, Kevin and Harriett form the "Circle of Justice" that sponsors the upcoming IHRAAM Tribunal and declares its intent to prosecute the churches and government of Canada for "crimes against humanity and Genocide."

<u>March 28:</u> In Port Alberni, the Circle of Justice holds a public forum for local survivors. One of them, Harry Wilson, is threatened by local state-funded tribal "chiefs" Ron Hamilton and Charlie Thompson, who tell Harry he will be killed if he talks about finding the dead body of a girl at the Alberni school in 1967.

<u>June 12-14:</u> In Vancouver, Kevin, Harriett and IHRAAM convene the first public hearing into crimes at Indian residential schools. Twenty tribal elders and IHRAAM observers are present. Local media ignore the event. Forty six former inmates of these schools describe having witnessed or been subjected to every act legally defined as Genocide at catholic, anglican and united church schools on the Canadian west coast between 1932 and 1984.

<u>June 16</u>: Kevin and Rudy James submit all of the evidence from the Tribunal to IHRAAM headquarters in New York City and to the United Nations High Commissioner for Human Rights, Mary Robinson, in Geneva; they call for charges of genocide to be brought against Canada and its churches at the United Nations. No reply is ever received.

<u>June 20</u>: The *Globe and Mail* reports the IHRAAM Tribunal and its submissions to the United Nations.

<u>July-September</u>: The Circle of Justice is sabotaged and destroyed from within and the first internet smear campaign begins against Kevin Annett. The campaign is organized by United Church officers John Siebert and Brian Thorpe, RCMP operative Jim Craven, and RCMP E Division "black ops" director Inspector Peter Montague.

<u>October 27:</u> First media report of the deliberate coverup of crimes by United Church and federal government at the Alberni indian school, based on information from Kevin and survivor Marlon Watts. (*Vancouver Province, p. A13*)

<u>November 1:</u> Kevin begins compiling all of the residential schools evidence into a single volume that will become *"Hidden from History: The Canadian Holocaust"*. He begins to receive death threats.

#### <u>1999</u>

<u>January 15:</u> First international reporting of the Canadian Aboriginal Holocaust is made by the acclaimed *New Internationalist* magazine, England *(Issue no. 309)*, based on evidence submitted by Kevin.

<u>February 1:</u> Government of Canada announces its plan to begin a "Healing and Reconciliation Fund" to award limited compensation to some residential school survivors.

<u>March-December</u>: Kevin and Harriett continue public protests at Vancouver churches and establish *"The Permanent Inquiry into Genocide in Canada",* which holds public forums and circles for survivors. Kevin publishes evidence that "at least 50,000 children died in the schools", based on documents revealing a constant death rate of between 40-60% for over a half century. (1889- 1947)

<u>April 10</u>: United Nations human rights panel declares Canada to be in violation of international law for its treatment of aboriginals. (Vancouver Sun, p. A14)

<u>April 30</u>: Kevin's doctoral studies program at UBC is sabotaged and he is forced to withdraw from the program, after United Church official and faculty member Murray Elliott blocks all funding for Kevin despite his first class marks. Kevin's thesis title was "*Genocide on the Coast: the Case of the United Church of Canada*". Kevin will eventually publish his thesis material as part of "*Hidden from History: The Canadian Holocaust.*" (2001) <u>June 1:</u> Over 10,000 lawsuits have been launched against Canada and the Anglican, Catholic and United churches for the residential school crimes.

<u>June 6:</u> First residential schools lawsuit in British Columbia concludes; the BC Supreme Court "Brenner Decision" finds both the United Church and government equally liable for harm done to children. This historic decision opens floodgates to further litigation.

<u>September-October</u>: The three guilty churches plead "possible bankruptcy" over the lawsuits and flowing from the Brenner Decision, and in return, the federal government declares its plan to assume "full liability" for the damages, despite the Brenner legal ruling.

# <u>2000</u>

<u>April 26</u>: Anglican church admits that children at its residential schools and at United and catholic schools were used in medical and drug testing experiments. (Vancouver Sun, p. A12)

<u>September 1</u>: In Vancouver, Kevin, Harriett Nahanee and fifteen others establish the first Truth Commission into Genocide in Canada. The Commission will continue the work of the IHRAAM Tribunal and will "seek to publicly prosecute the government and churches of Canada for their genocide of indigenous people."

<u>October 8:</u> Kevin is physically assaulted by two men in the downtown east side of Vancouver who tell him to "stop pissing off the chiefs".

#### <u>2001</u>

<u>February 1:</u> Kevin and the Truth Commission publish "Hidden from History: The Canadian Holocaust", compiling six years of evidence gathered by Kevin and others proving that genocide occurred deliberately in the Indian residential schools between 1889 and 1996. It is the first public report of this genocide.

<u>April</u>: Kevin is offered a spot on Vancouver Co-op Radio and begins a nine year long weekly public affairs program entitled *"Hidden from History"*. Countless witnesses to residential school and ongoing crimes against native people will speak on this program and name names. <u>September</u>: The Supreme Court of Canada overturns the Brenner Decision and absolves the three churches of direct liability, making the government "90% responsible" for the residential school crimes, all the evidence to the contrary. The government passes legislation restricting any future lawsuits and reducing compensation to survivors.

<u>December 28</u>: The Vancouver Province reports that the Catholic church hired "known convicted murderers and pedophiles" at its Christie Indian school on Vancouver Island.

# <u>2002</u>

<u>March 1</u>: All three churches and the federal government agree to awarding "limited compensation" to survivors **in return for a guarantee of legal immunity from further lawsuits and liability**. In effect the perpetrators have absolved themselves of responsibility for the residential schools genocide.

<u>April 20:</u> Kevin publishes another book, a biographical account called "Love and Death in the Valley". The United Church attempts to legally block its publication, and fails.

<u>November 10</u>: On Kevin's *Hidden from History* radio program, two aboriginal women claim to have seen RCMP officers abduct and kill Vancouver prostitutes at a "snuff film" operation run by the Picton brothers.

#### <u>2003</u>

<u>March 15:</u> An expanded second edition of "*Hidden from History*" is published, based on statements from more than 200 survivors. Detailed evidence of sterilization and medical experimentation on aboriginal children in United Church Indian hospitals in Nanaimo and Bella Bella, BC is described. The RCMP refuse to investigate sites near these hospitals where children are allegedly buried.

<u>August 7</u>: A secret Vatican policy called *Crimen Sollicitationas* is released to the London Observer: since 1929, it requires that all clergy cover up child rape and silence the victims, or face excommunication.

<u>November 16:</u> Kevin, Harriett Nahanee and two dozen aboriginals occupy St. James Anglican church in Vancouver and disrupt the service, and make the headlines demanding the return of the bodies of murdered residential school children, and the prosecution of all three churches for genocide.

#### <u>2004</u>

<u>February 11:</u> Truth Commission members attempt to survey grounds of the Mission (Catholic) Indian school based on reports of mass graves there. RCMP officers threaten them with arrest.

<u>June 5:</u> Former dorm supervisor at Anglican residential school in Lytton, BC tells Kevin Annett of mass grave of children "behind the main building", and of having seen children being "flogged to death and stuck in public stocks" between 1955 and 1962. Lytton RCMP refuse to investigate alleged grave site.

<u>September 30</u>: Kevin and the Truth Commission open a new investigation of mass graves at residential schools on Vancouver Island. The federal government attempts unsuccessfully to have Kevin's *Hidden from History* program canceled.

#### <u>2005</u>

<u>April 15:</u> The first National Aboriginal Holocaust Remembrance Day is held in Vancouver, featuring protests at churches. A new group called *"Friends and Relatives of the Disappeared"* (FRD) is formed in Vancouver, and later Toronto. Its organizers Kevin Annett and Harriett Nahanee demand the return of the remains of all the children who died "for a proper burial".

<u>September 10</u>: Federation of Mayan indigenous groups in Guatemala condemns Canada for its genocide of aboriginals, and petitions the United Nations to launch an inquiry.

<u>October 2</u>: Port Alberni RCMP claim "there are no graves of children" at the former residential school there, while admitting they have not investigated.

#### <u>2006</u>

<u>February 12</u>: FRD leader in Winnipeg, Chief Louis Daniels, dies suddenly in hospital while in good health.

<u>April:</u> Film maker Louis Lawless, Kevin Annett and Lori O'Rorke begin filming "Unrepentant: Kevin Annett and Canada's Genocide" on Vancouver Island, featuring eyewitnesses to residential school crimes.

<u>April 15:</u> FRD holds protests in Vancouver, Winnipeg and Toronto on the second Aboriginal Holocaust Day.

<u>December 5:</u> Just released film *Unrepentant* wins Best Director award at the New York Independent Film Festival.

# <u>2007</u>

<u>January 15</u>: *Unrepentant* wins best documentary award at the Los Angeles Independent Film Festival. The film is widely viewed in the aboriginal community and globally, with a half million views on the internet.

<u>February 24</u>: FRD founder Harriett Nahanee dies suddenly after being imprisoned after an FRD protest.

<u>March 8</u>: FRD occupy Catholic churches in Vancouver and Toronto just before Easter, calling for the arrest of Pope Benedict for covering up genocide and child trafficking. The location of mass graves of children at twelve former residential schools is named by Kevin to reporters, and the church occupations are widely reported in Canadian media.

<u>April 15:</u> At the third Aboriginal Memorial Day rally in Vancouver, Kevin Annett announces to the press that the FRD will file a suit in international courts to have Canada and its churches indicted for genocide.

<u>April 24:</u> The Globe and Mail prints front page article entitled "Natives Died in Droves as Ottawa ignored Warnings", in which the fifty percent death rate in the residential schools is confirmed. Kevin Annett is quoted in the article and was the main source of documentation for it.

<u>April 25:</u> Media reveals that the Canadian government deliberately destroyed "thousands" of residential school records to erase evidence of the deaths of children. (24 Hours News)

<u>May 1:</u> In Parliament, MP Gary Merasty calls for the return of native children's remains from residential schools. Aboriginal Affairs Jim Prentice replies by announcing upcoming government "apology" and "Truth and Reconciliation Commission", without mentioning the massive death rate.

<u>September 19:</u> Government establishes the Indian Residential Schools Settlement Agreement (IRSSA) to control the evidence of genocide and defuse lawsuits. The IRSSA offers limited compensation, creates a whitewash "Truth and Reconciliation Commission" with no power to subpoena or prosecute, and legally indemnifies itself and the churches for any legal liability for the residential school crimes.

# <u>2008</u>

<u>March 8</u>: Kevin issues to national media a comprehensive list of twenty eight mass graves of children at former residential schools, mostly in western Canada.

<u>March 17, 24:</u> Massive FRD protests occupy five catholic, anglican and united churches in Vancouver and Toronto.

<u>June 11:</u> Government "apology" for the residential schools is read by Prime Minister Stephen Harper in Parliament; he does not mention dead children or the culpability of the churches. Party leaders speak. Only Gilles Duceppe of the Bloc Quebecois mentions dead children and mass graves.

<u>June 15</u>: The state funded "Truth and Reconciliation Commission" is officially launched, without any power to subpoena or prosecute. FRD and aboriginal groups call for its boycott, and call instead for an international Tribunal to prosecute Canadian church and state.

<u>September 10</u>: FRD leader and Nishga native Carol Martin calls for disruption of 2010 Olympics if bodies of residential school children are not returned.

#### <u>2009</u>

<u>March 15</u>: Kevin Annett, Carol Martin and FRD members are invited to speak in London and Rome by native rights solidarity groups. Kevin and Carol publicly call for Vatican and Church of England to disclose the buried location of children who died under their care. <u>June 20</u>: The United Nations Permanent Forum on Indigenous People issues a call for Canada to be investigated for genocide.

<u>October 11:</u> Kevin Annett performs first public exorcism and memorial service outside the Vatican in Rome. Tornado strikes Rome the next morning.

<u>November</u>: European media begin to report Pope Benedict's personal role in covering up rape and child trafficking in the Catholic church.

<u>December 9:</u> FRD leader Johnny Bingo Dawson dies after a savage beating by three Vancouver policemen. Official cause of death is alcohol poisoning, despite toxicology report that shows there were no drugs or alcohol in Bingo at time of death.

# <u>2010</u>

<u>April 8:</u> Kevin performs second exorcism at the Vatican. He and a delegation of residential school survivors meet with Italian politicians of the Democratic and Radical parties and the European media, and call for sanctions against Canada for its genocide.

<u>June 15:</u> The International Tribunal into Crimes of Church and State (ITCCS) is formed in Dublin by six organizations, appointing Kevin Annett as its Secretary.

<u>July 20</u>: Kevin Annett is arbitrarily banned from the government-funded Vancouver Co-op radio and his program "Hidden from History" is cancelled.

<u>September 18:</u> 20,000 people protest in London against Pope Benedict's visit; ITCCS speakers including Kevin Annett call for Benedict's arrest and trial.

<u>September 19</u>: Pope Benedict and Queen Elizabeth sign "Holyrood Agreement", placing the crown and church of Eengland under papal authority and the "crimen sollicitationas" policy of protecting child raping priests

# <u>2011</u>

<u>February 26</u>: FRD activist and an eyewitness to Queen of England's abduction of ten children, William Combes, dies suddenly while in good health, at Vancouver General Hospital. William was scheduled to give his testimony to an ITCCS inquiry in March.

<u>April 12</u>: Kevin Annett and the ITCCS are invited in writing by ten Mohawk elders to search for the remains of children who died at Canada's oldest Indian residential school in Brantford, Ontario.

<u>May 29</u>: Kevin Annett is detained at Stansted airport in London and deported from England prior to his addressing a rally denouncing church and state child trafficking.

<u>September 29 – October 11:</u> Kevin, Mohawk elders Bill and Cheryl Squire, and a team of forensic specialists commence ground penetrating radar search for reputed mass graves at the former Mohawk Indian school in Brantford. (see complete report at <u>http://itccs.org/mass-graves-of-childrenin-canada-documented-evidence/</u>

<u>November 21-24</u>: The ITCCS team commences test archaeological digs at two locations near the former Mohawk school. Human bones and buttons off school uniforms are uncovered and positively identified.

<u>December 1</u>: Consulting archaeologists agree that some of the bones are human, belonging to small children. Samples are sent to the Smithsonian Institute. A "smoking gun" document from Anglican church archives is surfaced by Mohawk Leona Moses, showing plan by the crown and church of England to exterminate Mohawk children through the residential school.

<u>December 20</u>: State funded Mohawk chiefs derail the inquiry with smears and payoffs. Further excavations are halted.

# <u>2012</u>

<u>January 3</u>: Eyewitness to the police killing of Bingo Dawson, FRD activist Ricky Lavallee, dies of severe blow to the chest.

<u>January 9</u>: Archbishop of Canterbury Rowan Williams personally orders Canadian Anglican Primate Fred Hiltz and London, Ontario Bishop Bob Bennett to destroy any evidence linking the British royal family to the rape or killing of children at the Brantford Mohawk school. Bennett personally pays off and silences Mohawk elders who endorsed Kevin Annett and ITCCS. <u>February 5</u>: Human Rights Watch in New York publishes a report accusing Vancouver police of systematically targeting and torturing aboriginal men, and raping native women.

<u>May 3:</u> FRD activist and eyewitness to murder at Alberni residential school, Harry Wilson, dies of unknown causes in Vancouver.

<u>September 15</u>: The International Common Law Court of Justice (ICLCJ) is convened in Brussels, to prosecute Pope Benedict, Elizabeth Windsor and 28 others for crimes against humanity.

# <u> 2013:</u>

<u>February 6</u>: The Vatican receives a diplomatic note from the Spanish government, stating that an arrest warrant could be issued against Pope Benedict within Spanish territory.

<u>February 11</u>: Pope Benedict suddenly resigns from his office.

<u>February 25</u>: The ICLCJ jury issues its verdict, finding Pope Benedict, Queen Elizabeth, Canadian Prime Minister Harper and 27 others guilty of committing and concealing crimes against humanity. All of the defendants are sentenced to 25 years in prison and the loss of their wealth and authority. Arrest warrants are issued.

<u>July 3:</u> The new Pope Francis, Jorge Bergoglio, reaffirms "*Crimen Sollicitationas*" policy of the catholic church, requiring that all clergy conceal child rape.

<u>August 31</u>: Cardinal Tarcisio Bertone, a convicted defendant in the ICLCJ trial, resigns as Vatican Secretary of State.

<u>September 10</u>: Kevin Annett is nominated for the Nobel Peace Prize by scholars in Canada and the USA.

# <u>2014</u>

<u>January 16:</u> Former Argentine civil servant testifies to ICLCJ officers that Jorge Bergoglio (Pope Francis) was present at meetings to plan the abduction and trafficking of children of political prisoners <u>February 25</u>: ICLCJ stand down order is issued to all agents of the crown of England and the church of Rome, on the first anniversary of them and their chief officers for crimes against humanity.

<u>March 31</u>: Canadian government finally acknowledges that "tens of thousands" of children died in Indian residential schools, validating Kevin Annett's work and claims. (<u>http://westcoastnativenews.com/tens-of-thousands-first-nation-children-died-in-residential-schools/</u>)

<u>April 7:</u> Second ICLCJ case, prosecuting global child traffickers, commences. Primary defendants are Jorge Bergoglio (Pope Francis), Jesuit head Adolfo Pachon, and Archibishop of Canterbury Justin Welby. All three men were issued public summonses to the court on March 3, and failed to respond. (see below \*\*\*)

<u>April 20:</u> Easter Maastricht Proclamation nullifies the authority of the church of Rome, and releases their agents and members from allegiance to that entity. Proclamation is read publicly and posted by Kevin Annett at the oldest catholic church outside Rome, in Maastricht, Holland.

<u>May 25:</u> Indicted defendant Adolfo Pachon announces his resignation as head of Jesuit Order.

<u>June 13</u>: AnneMarie van Biljenburgh, eyewitness to child sacrificial rituals in Belgium and Holland, gives testimony to the ICLCJ. She and three other witnesses describe seeing the defendants (Bergoglio, Pachon, Welby) participating in human hunting and sacrificial rituals since 1997.

<u>July 18</u>: ICLCJ finds all three defendants guilty as charged of crimes against humanity, and they are sentenced to life imprisonment in absentia. Arrest warrants are issued against them.

<u>August 15</u>: Ninth Circle sacrificial ritual in Montreal stopped by special action unit attached to ICLCJ. The unit is assisted by elements in the Montreal and Ottawa police.

<u>September 9</u>: Mass grave of murdered babies is uncovered in Tuam, Ireland. Cardinal Sean Brady, named as chief agent of the coverup of this Ninth Circle slaughter, resigns as top catholic official in Ireland. <u>September 20</u>: Kevin Annett is re-nominated for the Nobel Peace Prize by scholars in Canada and the USA. <u>September 25</u>: Acting on ITCCS information, Interpol arrests more than 1000 European child traffickers and releases 30 children held in locations identified by Kevin Annett and ITCCS.

<u>September 29</u>: Ottawa detective Kal Ghadban, who assisted ICLCJ in Montreal action against Ninth Circle, is murdered.

<u>October 1</u>: Top Canadian politician Denis Lebel is named as participant in Ninth Circle sacrifice in Rome, previous February 21-22.

<u>November 8</u>: Twelve Mile Club, a child sacrificial cult in Vancouver, Canada, is targeted by new Grand Jury investigation launched by upcoming Republic of Kanata.

<u>November 29:</u> RCMP stand down from Kinder-Morgan protest in Vancouver after being issued Stand Down order from local common law court of Justice.

#### <u>2015</u>

<u>January 15</u>: The Republic of Kanata and its High Court of Justice is established under common law. It replaces the former jurisdiction of Canada and the crown of england, and creates local common law courts.

March 1: Radio Free Kanata goes on the air.

# Adjudication in the The Case of the Pope: Global Child Trafficking and Murder

#### Summary:

The common law trial in absentia of the three top officials of the Vatican and the Church of England - Jorge Bergoglio, Adolfo Pachon and Justin Welby - began last Monday, April 7 with the opening arguments of the Citizen Prosecutor. The Court convened in closed session under tight security, presided by five Magistrates and a complete Court room staff, along with twenty seven sworn Jury members.

The Prosecutor has spent the past three days presenting affidavits or videotaped statements from sixteen (16) witnesses from Canada, the United States of America, England and Holland. These witnesses' statements and evidence address the complicity of the Defendants or their agents in the sexual and financial trafficking and the ritual rape, torture and murder of children in these countries.

The Prosecution will be calling upon the first of these witnesses to be present in Court for examination and questioning commencing the week of Monday, April 14, when the Special Assistant to the Prosecutor, Reverend Kevin Annett, will also be present in Court to give testimony and assistance.

Here are some details from the Prosecution's case evidence:

The Prosecution's evidence falls into three categories: Institutional Genocide, Child Sacrifice and Ritual Killing, and Child Trafficking. Each of these will be addressed by the witnesses and corroborating material.

The sixteen witnesses in this first round of evidence have direct, firsthand experience and knowledge of the role of the Defendants and their agents in all of these crimes, including in the so-called NINTH CIRCLE child sacrificial cult. Besides participants in this cult and survivors of government experimental programs, these witnesses include former officials of the Roman Catholic and Anglican churches, retired and serving policemen, indigenous elders, a retired senior politician from England, an operative of the Canadian Security and Intelligence Service (CSIS), and a former civil servant in the Argentine military junta.

The Prosecution has also received an affidavit from Rev. Kevin Annett, ITCCS Field Secretary, that connects his own victimization by church and state in Canada with his discovery of the activity of NINTH CIRCLE members at Indian residential schools across Canada, and with the continued murder of indigenous women and children by this Circle on the west coast of Canada. Rev. Annett will appear in Court next week, sometime after April 14, to be examined by the Prosecution and present further evidence.

Former NINTH CIRCLE participants whose evidence was presented in Court last Tuesday, April 8 testify that Cree Indians in northern Canada are being continually targeted by the Circle for torture and murder because of the valuable uranium resources on their lands which are coveted by the United States military and corporations associated with the NINTH CIRCLE and their adherents within both the American and Canadian governments. The names of prominent Canadian and American politicians and corporate officials who engage in these Circle ritual killings have been named in Court and entered into the evidence record.

The NINTH CIRCLE began at least three centuries ago in the Vatican but has expanded to embrace local satanic child sacrifice cults across Europe and the Americas. Thanks to Catholic pressure, the Circle affiliated strongly with Nazi cultic groups that had close ties with the Waffen S.S. during the 1930's and '40's, including the so-called KNIGHTS OF DARKNESS, whose members included former Pope Benedict, Joseph Ratzinger. Many of these members continued their murderous acts against children after World War Two, especially in Canada. Testimony was received from the sole survivor of a Knights of Darkness cult at the former Royal Canadian Air Force Base known as Lincoln Park in Calgary, Alberta. The Witness observed the ritual torture and killing of twenty abducted children by a former SS doctor and three other "Knights" working under cover as Canadian military personnel, between the years 1956 and 1958. Records of the SS doctor codenamed "Major Bob Armstrong" (SS number "091374 SS") have been confirmed by Canadian government documents obtained by the Court from a former official of the Canadian Military Intelligence Agency, the NIS.

Other witnesses to NINTH CIRCLE cults confirm the presence of British Royal Family members MOUNTBATTEN and PRINCE PHILIP at these child sacrifices, whose presence was concealed by defendant WELBY. Jesuit officers including defendants PACHON and BERGOGLIO were also present at the same rituals at Carnarvon Castle in Wales and at an undisclosed French Chateau, during the 1980's and 1990's. Similar sacrifices were conducted at Catholic and Anglican Indian residential schools in Kamloops, British Columbia and Brantford, Ontario during the 1960's and earlier, according to statements from living and deceased indigenous eyewitnesses.

7. A massive child trafficking network operating through official Roman Catholic adoption, "planned parenthood" and foster care agencies was described by a witness with inside knowledge of this network and its coordination through a special office at the Vatican. This office siphons children into NINTH CIRCLE cultic activity and child sexual trafficking networks around the world, according to another witness, a former employee of the Curia in Rome.

8. An eyewitness to the personal involvement of Pope Francis, Jorge Bergoglio, in such child trafficking in Argentina during the reign of the military Junta has presented his affidavit to the Court. He is a former civil servant with the Junta and is in protected custody in Spain. He will appear before the Court to corroborate his statement.

Further evidence of the Prosecution will be disclosed in upcoming bulletins, and according to the decisions of the Court Magistrates.
